

Jacksonville Real Estate Investor's Association VENDOR PROGRAM

AVAILABLE VENUES - We have advertising packages available with cost ranging from **\$50.00 up to \$500** per year. Understanding that Vendors needs and budgets vary widely we have designed the following venues...

1. **Online JaxREIA Vendor Coupon** - (this MUST be included and is the minimum available venue)
This is an online coupon available for download and printing from our website. A coupon will be published on the JaxREIA website and promoted by JaxREIA leadership as an exclusive discount for JaxREIA members. The discount must be a “real” advantage for our members. The coupon will include a business card size company/service description and a description of the discount. The coupon will be published quarterly and run for one year. Once you are approved, a JaxREIA representative will contact you to collect the information for the coupon book. If you have a business card available, *you may expedite the coupon publishing by submitting it with the application.* The current cost of this venue is **\$50.00 per year.**
2. **Projector Screen Slide at Main Meetings** – We project a “rolling” power point slideshow on a large screen during the pre-meeting networking time at every main meeting. You may place a one page slide on this program (you provide the layout or we will design for a \$25 one time fee). The current cost of this venue is **\$100.00 per year.**
3. **Brochure Table** – We provide a presentation area at our monthly main meetings with an 8 ½” X 11” acrylic media holder and a space for your company brochures or handouts. We will set out and put away the acrylic holders each meeting. Please note that it is your responsibility to place and/or pick-up the handouts. We will clean the table and dispose of any handouts left after each meeting. The cost of this venue is **\$100.00 per year.**
4. **½ Table Sales Space at Main Meetings** (approximately 3 ft wide X 2 ft deep) Up to two representatives may attend the sales table with media as space allows. We make every effort to arrange the sales tables so as to provide maximum exposure to attending members. The cost of this venue is **\$40 per month or \$200/year.**
5. **Vendor of the Month** As our exclusive “Vendor of the Month”, you will be allocated a five minute sales presentation before the entire Main Meeting audience, plus an “advertorial” type article in our monthly newsletter. The main meeting emcee will also introduce your company in a positive manner. You can provide your own article or we can compose it for you with the use of a simple question that you fill out. This venue is on a first-come first-serve basis and is limited to one month per year per vendor. The current cost for this venue is **\$100 per month.**
6. **Professional Venue Package**– Recognizing that there are Vendors that will profit from maximum exposure to our membership, we are offering discounted packages which includes the following:
 - a. **Items #1 thru #4** – The current cost for this combined venue is **\$425 per year**
 - b. **Items #1 thru #5** – The current cost for this combined venue is **\$500 per year**
